We would like to invite you to participate in the **Ad-Hoc Technical Advisory Group (ATAG)** activities for the [European Digital Identity Wallet \(EUDIW\)](#). The Ad-Hoc Technical Advisory Group (ATAG) consists of subject-matter experts who are asked to provide technical guidance for the design of the EUDIW and its [Architecture and Reference Framework \(ARF\)](#), contributing to the Wallet's successful implementation to approximately 447 million EU citizens.

Under the Electronic Identification, Authentication and Trust Services (eIDAS) Regulation, the European Commission aims to implement an EU-wide decentralized [European Digital Identity Wallet \(EUDIW\)](#). The Wallet will be a product of collaboration between EU Institutions and the Member States. Each Member State will offer a Wallet to citizens, residents, and businesses in the next years. Also, each Wallet will be interoperable – according to the EUDIW ARF – and handle the same type of documents (e.g., mobile driving licenses, e-diplomas) and digital identities (incl. attributes such as name, date of birth, and nationality). The Wallet Holders will be able to securely authenticate, store, present, share, and sign documents across multiple public and private services.

**Together with other experts, you will be participating in the following activities:**

- Participate in one (1) Informative Session (est. 2 hours): The purpose of this session is to inform the ATAG experts about the overall initiative and points to be discussed.
- Fill-in a Short Questionnaire (est. 15-20 minutes): Provide pointers to ongoing challenges and/or approaches related to your expertise.

- Participate in two (2) Interactive Sessions (est. 2 hours each): These dedicated sessions will allow the ATAG experts to interact one with another, discuss, and provide feedback in detail. **Note:** More sessions might be scheduled depending on the development of the discussions.
- Provide additional feedback on a shared collaborative space, i.e., Confluence (est. 30-60 minutes): Further discuss, highlight challenges, and provide suggestions.
